1. Introduction:

Adani TotalEnergies E-Mobility Ltd (ATEL) is a fully owned subsidiary of Adani Total Gas Limited and developing EV Charging Infrastructure across India. EOI is for consultancy for electric power connection (LT) services for electric vehicle charging stations in the following states:

Priority 1 : Tamil Nadu, Telangana, Andhra Pradesh, Chhattisgarh, Jharkhand,

Bihar, Madhya Pradesh, Kerala and Goa

Priority 2: All other states of India.

2. Scope of Work:

- 2.1. Application filling for new EV connection.
 - a. Intimation of Location to LEC by ATEL
 - b. LEC to provide the list of mandatory compliance documents applicable w.r.t DISCOM to the ATEL Team.
 - c. ATEL will provide the necessary documentation required for filling the EV application to LEC.
 - d. In case of any incomplete / OR Specific documentation required by the respective DISCOM in the state – LEC will support collection of said documentation from the respective Location Partner as an additional scope.

TAT: 3 Working Days w.r.t Date of Intimation by ATEL

- 2.2. Mapping of respective DISCOM organization
 - a. Sub-division office.
 - b. Division office
 - c. Circle office
 - d. Submission of Contact details of DISCOM dealing office to ATEL Project Manager
- 2.3. Documentation and mandatory compliance.
- 2.4. Site survey & demand note generation.
- 2.5. Follow up with the ATEL team for payment against the Demand note.
- 2.6. In case of exorbitant SLD charges liaisoning with DISCOM officials for revision of Demand Note.



- 2.7. Payment Submission and acknowledgment
- 2.8. Follow up for meter release & commissioning.
- 2.9. Follow up for electrical auxiliary equipment like H-Pole, Transformer, etc, (if applicable as per the site survey)
- 2.10. Test report endorsed by applicable competent authority.
- 2.11. Final commissioning EV connection

3. Qualification Criteria:

- Vendors/Consultants should have prior experience for obtaining LT power connection for EV Charging Stations.
- Contractors with prior experience of obtaining EV Connection for leading CPOs (charger points operator) shall be preferred.
- Contractors with Class A or DISCOM approval certificate shall be preferred.

4. Submission Requirement:

- Company Profile
- Experience letters of similar carried out works.
- Copies of Purchase orders of similar carried out works.
- Financial Statements for 3 Years

5. Terms and Conditions:

Unit Rate: Inclusive of all the work mentioned above.

Payment Terms: 100% after completion of work and energization of the site.

Completion Period: Vendor shall complete the scope within 45 days of intimation. We have mentioned the timelines for each activity is attached below as Annexure A. LD of Rs 500 per day shall be deducted for the delay beyond the agreed period.




Fig.- Annexure A: SOP for Scope of work
