Terms and Conditions for the supply of Piped Natural Gas (PNG) to Domestic customers

Following Terms and Conditions will apply and govern the connection and supply of Piped Natural Gas (PNG) to Domestic customers (Buyer) by Adani Total Gas Limited ("Seller").

DEFINITIONS:

- **"Application"** means the request for a PNG connection in the format / form designed by Seller and duly filled and signed by the Buyer
- "Buyer" means the applicant who has been provided PNG connection by the Seller as per the terms and conditions mentioned herein.
- "Connection" means installation of combination of one or more pipelines, related fittings valves, regulator, meter, rubber tubing and any other associated equipment provided by Seller in Buyer's premises in order to supply PNG to the Buyer.
- "Invoice" means a periodic statement generated by Seller showing details of various charges applicable for consumption of Natural Gas, minimum usage charges, non refundable charges for extra connection or work undertaken (if any) by the Seller at the Buyer premises and the total amount including taxes and levies payable by Buyer to the Seller for (iv)
- use of gas for a particular period.

 "Last Mile Connectivity" means connectivity between the Riser Isolation Valve (RIV) before the metering unit and the safety hose pipe connecting the burner in the Buyer's
- . **"Measurement Equipment"** means such main and subsidiary meters, including apparatus, regulators, guages, valves, pipes and other related accessories and fittings, installed at Buyers premise as the Seller considers necessary for the measurement and recording of the volume of natural gas in Cubic Meters or Standard Cubic Meters and Pressure in Kg/cm2 or Bar or mBar or any other unit at the Delivery Point for the safe operation of the Seller's 8-Buyer's Facilities.
- "MMBTU" means One million British Thermal units. A British Thermal unit (BTU) is defined as the amount of heat required to raise the temperature of one pound of liquid water by one degree from 60° to 61°Fahrenheit at a constant pressure of one atmosphere.
- "Network Tariff" means the unit rate of tariff (excluding statutory taxes and levies) in Rs/SCM or Rs./ MMBTU or any other such unit prescribed by PNGRB, chargeable by the Seller for the infrastructure installed by the Seller for providing PNG to the Buyer.
- "Planed Works" shall mean works conducted over a period of hours or days identified in advance on the Seller's Facilities by the Seller, which may temporarily restrict the Seller's Facilities and shall include modifications to, enlargement of, repairs to or maintenance of the (a) Seller's Facilities and (b) upstream of the Seller's Facilities which may result in temporary reduction/stoppage of PNG to the Buyer.

 "PNG" means natural gas supplied by pipelines for domestic/commercial/industrial use
- "Gas Price / PNG Price" means unit price of PNG in Rs/SCM or Rs/MMBTU or any other such unit prescribed by PNGRB.
 "PNGRB" means Petroleum and Natural Gas Regulatory Board established under sub-(xi)
- (xii) ction 3 of the PNGRB Act.
- "**PNGRB Act"** means Petroleum and Natural Gas Regulatory Act, 2006 of 2006
- "Premises" or "Site" or "Property" means the property owned or occupied by the Buyer in which the Buyer has got PNG connection from the Seller or is desirous of getting a PNG connection.
- "Seller" means Adani Total Gas Ltd., a company incorporated under the companies act, 1956 and having its registered office at "Adani House", Mithakhali Six Roads, Navrangpura, and Ahmedabad 380009.
- "Seller's Facilities" means the Seller's pipelines, gas plants, machinery, measurement equipment, metering facilities, pressure regulating stations, and other equipments necessary for flow control and processing, compression, measuring and testing of Gas to nable délivery of Gas to the Buyer
- "Standard Cubic Meter" or "SCM" shall mean the quantity of Gas that occupies a volu
- "Standard Cubic Meter" or "SCM" shall mean the quantity of Gas that occupies a volume of one (1) cubic meter at a temperature of fifteen degrees Celcius (15°C) under absolute pressure of one decimal zero one three two five bar (1.01325 Bar).

 "Tariff Card" means a document prepared by Seller and revised from time to time indicating various charges which include Refundable Interest Free Security deposit, PNG Sales Price, Network Tariff, other charges and charges for any extra connection or work undertaken (if any) by the Seller at the Buyer premises.

- By execution 8 submission of the Application along with the refundable interest-free security deposit as mentioned in the tariff card, Buyer shall be deemed to have unconditionally agreed to and accepted connection and supply of PNG on the Terms & Conditions herein contained, and these Terms and Conditions shall constitute a binding

- Conditions herein contained, and these Terms and Conditions shall constitute a binding agreement between the Seller and the Buyer. Application received without the refundable interest free connection security deposit shall not be considered as a valid application for PNG connection. On submission of the application along with the refundable interest free connection security deposit by the Buyer to the Seller, the Seller shall commence the process to provide PNG connection to the Buyer. The Seller will carry out a technical survey of the Buyer's Premises and shall determine the location and manner of laying pipeline and installation of meter and other equipments for supply of PNG. The installation activity shall be carried out by the Seller / its authorized Vendor or Contractor.

 The seller reserves the right to cancel without prejudice the Application on the grounds of technical non-feasibility, non availability of permissions from the authorities, safety or hazard concerns or any other grounds which the Seller deems fit. Seller can refuse the gas connection and / or cancel registration without giving any notice to the Buyer. The Seller shall refund the interest free refundable security deposit submitted by the Buyer in full in case of refusal of Application or cancellation of registration. In all such cases the decision of the Seller shall be final. of the Seller shall be final.

 A single connection means provision of PNG for use in one kitchen per premise. However, extension from the kitchen can be provided to connect maximum two appliances, such as, geyser, etc. in the same floor at additional charges as determined by the Seller from time to time. Two separate kitchens on same / different floors in the premise shall be treated as two PNG connections and separate meter shall be installed. Extension from one floor to another shall also be treated as new connection. All charges will be payable by the Buyer to the Seller for such extension activity as per Tariff Card.
- The supply of PNG shall be commenced after necessary testing by the Seller and necessary
- approvals and permissions, if any required, being received.

 The Seller reserves the right to supply PNG to other Buyers, through the same pipelines, at any point before inlet of the meter installed at the Buyer's premises.

- any point oerore inject of the meter installed at the Buyer's premises. All above ground pipelines shall be exposed and painted with GOLDEN YELLOW colour by the Seller. In no case Buyer shall tamper with or change the colour of the pipeline. Quantity of pipeline and other fittings materials specified for Single Domestic PNG connection is only for that particular connection and cannot be adjusted / clubbed with the quantity of Pipelines and other fittings materials for the other points/connection. Under no circumstances. G.I or Copper pipelines shall be concealed in wall or furniture.
- Maximum flow of Natural Gas in Buyers premises is limited to 2M²/hour. Hence provision for consumption points will depend on the site situation and professional judgment of the site engineer, which shall be final and binding to the Buyer. Only One number of Wire Braided Flexible Hose provided by the Seller should be used for
- connecting Gas Tap. Use of additional 'Hose' should be strictly for bidden.
 Wire Braided Flexible Hose must be installed in the same room where the appliance is installed, and it shall not pass through walls, floors, cabinets or other partitions.

CHARGES:

 For any extension / modification, relocation / alteration of the pipeline / meter / regulator or any part of the connection, Buyer shall request Seller in the format prescribed by Seller. Seller upon receiving such request shall promptly carry out the requested modification. Buyer shall pay charges to the Seller as applicable at the time of execution of work as mentioned in the 'Tariff card'. In no case, the Buyer shall have any right to modify / alter the connection. If, it is found that, the connection has been modified / altered / tampered in part or whole by the Buyer, Seller at its sole discretion may discontinue the supply of PNG, levy penalty or forfeit the security deposit. Seller's decision in all such matters shall be final. Any modification / alteration required in the gas connection shall be carried out by the Seller only and it would be charged additionally as per Tariff card prevailing at the time of execution of the work.

Advance payment if any, made by the Buyer to the Seller at the time of registration, other than Refundable Interest Free Security Deposit, will be adjusted against charges for "Extra Work/ Services". If the total charges of Extra Work/ Services done by the Seller are less than advance payment made by the Buyer, necessary credit will be given in the gas bill. All charges paid by the Buyer for extra work/ services other than refundable interest free security deposit mentioned in clause 2.1 will be pore refundable. will be non refundable.
- Tariff Card' then prevailing at the time of 'execution of work' shall be applicable & binding to the Buyer. Revision in 'Tariff Card' is at sole discretion of the seller and may be changed without notice to the Buyer.

INVOICING:

- The meter installed by the Seller measures the gas in Cubic Meter. The reading (in Cubic Meter) of the meter can be converted into Standard Cubic Meter (SCM) and MMBTU by applying factors which depend on delivered pressure of gas, temperature of gas, composition of gas, etc. These parameters are averaged over the billing period to determine the average correction factor for the period. The Seller reserves the right to determine and apply the correction factor from any date without giving any notice to the Buyer. The Seller also reserves the right to break the current gas price into various components as may be required.
- Invoice shall be sent to the Buyer at the end of every invoice period in Rs/MMBTU or any other unit prescribed by PNGRB with detailed break up of various components like Gas price, network tariff, last mile connectivity charges, taxes, duties and levies etc. as applicable and payable for the relevant period. Every invoice shall be paid by the Buyer in full by Cheque/DD/Pay order/Cash by the due date mentioned on the invoice.
- Cheque/DD/Pay order for the invoice amount should be made by the Buyer in the name of "ADANI TOTAL GAS LTD." and deposited at the payment collection centers indicated by the
- In the event of failure of the meter to record correct consumption, the quantity of PNG consumed by the Buyer shall be determined on the basis of the average consumption of last two months or on any other basis as determined by Seller. The decision of Seller in such a case shall be final.
- Non receipt of invoice shall not be sufficient ground for non-payment of outstanding amount. In case Buyer does not receive the invoice he/she is under obligation to obtain duplicate copy of the same from the supplier. The Buyer shall pay to the Seller late payment charges as mentioned in the schedule of charges on all the delayed payments from the due date until payment and / or realization.
- In case of any dispute the Buyer shall pay the invoice amount in total by the due date and then lodge a complaint with the Seller. All complaints shall be dealt with within a stipulated time frame and if the claims made by the Buyer are found to be correct same shall be adjusted in the next invoice by the Selle

OBLIGATION AND UNDERTAKING OF THE BUYER:

The Buver shall:

 Prior to the commencement of PNG supply, at its own cost obtain all necessary consents, approvals and permits from all relevant authorities including RWA, society administration, housing society / association, joint owners, landlord as the case may be, required to obtain the PNG connection. The Buyer shall, also be responsible at its own cost for obtaining all easements or rights of way through any private property of any other person inside the society / colony / sector or RWA, society administration, landlord, etc. for laying of pipeline for supply of PNG.
 Use the PNG only for domestic or household purpose, such as cooking and water heating at the premise mentioned in the application form and shall not use / permit / allow the usage of PNG for any other purpose.
 Take adequate precautions and all safety measures in connection with the supply to and

- Inform and thereby take permission of the Seller in case of any construction / renovation /

- Permit the Seller / its authorized representative access to the premises for the purpose of Permit the Seller / its authorized representative access to the premises for the purpose of meter reading, laying pipelines, to alter or replace any pipeline, inspection, maintenance check up, installation of equipment, if the Seller in its discretion determines the same to be necessary or expedient by verifying the identification of such authorized representative. OWNERSHIP:

OWNERSHIP:
The pipes, all equipments, other installations and facilities provided for the purpose of supplying PNG, up to the inlet of the stove including the wire braided flexible hose shall be and remain the property of the Seller at all times and the Buyer shall not have or claim any right, title or interest therein. All the pipes, equipments and installations provided for the purpose of supplying PNG shall be removed in case of termination of this Agreement and/or discontinuation of PNG Supply.

TERMINATION:

- Without prejudice to the other rights of the Seller, the Seller may by giving 15 days notice terminate the agreement with the Buyer, if:

- The Buyer fails to pay the seller any sum due to the Seller under these Terms and Conditions and / or otherwise within 30 days from the due date for payment thereof. Buyer fails to comply with any of its obligations and/or commits any breach of the covenant or conditions on his part to be observed, performed or fulfilled, ii)

- Particulars as furnished by the Buyer in the Application are found to be false or incorrect. PNG is not consumed by the Buyer for a continuous period of 26 weeks without informing the Seller
- Buyer tempers / modifies / alters the connection without the consent of the Seller.

- Buyer may request for termination of PNG supply / connection, by giving written notice of 8.2 O1 (One) month to the Seller.

In the event of termination of the PNG supply, without prejudice to the other rights of the Seller, i) The Seller will remove all pipelines, installations and equipment installed by the Seller for the supply of PNG at the cost of Buyer. ii) The Buyer shall be liable to pay to the Seller all amounts due and payable by the Buyer to the Seller upto the date of termination of the agreement. DISCONNECTION

The Buyer may request for temporary disconnection of PNG supply for a period of one menth or more by applying in the prescribed format to the Seller along with disconnection charges. After receipt of the request the Seller will arrange to temporarily disconnect the PNG supply and record the meter reading and accordingly raise invoice for PNG usage and related charges. After receiving the total payment against the invoice as per the meter reading taken, the Seller will proceed for disconnection. During the disconnection period

- invoicing will not be done for the Buyer. 9.2 Seller may disconnect PNG supply/connection to any premise for safety reasons. In such cases, Seller shall, as soon as possible, intimate the Buyer for such disconnection and provide schedule/time of reconnection.
- In case the Buyer fails to pay the invoice sent by the Seller for two consecutive times, supply of PNG shall be stopped immediately. The Buyer shall be liable to pay charges for such disconnection and reconnection as per 'Tariff Card'.

10. RECONNECTION:

- In case the Buyer applies for reconnection of PNG supply, after termination / temporary disconnection, all the reconnection/ re-commissioning charges (as determined by the Seller) and outstanding dues shall be paid by the Buyer by demand draft, except in case of disconnection carried out because of reasons mentioned in clause 9.2. Only after full payment of all dues reconnection will be considered.

 Reconnection of PNG supply will be at the sole discretion of the Seller and the Seller may refuse the same, by giving valid reason.

SHIFTING OF RESIDENCE: In case, a Buyer desires to shift from the present premises having PNG connection to new premises, Buyer will have to surrender the present connection and settle all dues and reapply for a fresh PNG connection at the new address. In no case, Buyer shall on his own, remove, shift, dismantle, modify, alter the meter, pipeline and / or any other pipeline installations.

TRANSFER OF OWNERSHIP OF THE CONNECTION:

TRANSFER OF OWNERSHIP OF THE CONNECTION:
Seller permits transfer of the PNG connection from one name to another name in the event of sale / purchase of the property, demise of the registered Buyer, etc. Such transfer is permitted subject to the payment of administrative charges as may be applicable, from time to time by the Buyer to Seller as indicated in the Tariff Card in all cases, except in case of transfer of PNG connection to the legal heir of the Buyer upon demise of the Buyer where no administrative charges are applicable. The transfer of PNG connection from one name to another name is subject to submission of necessary documents, as may be required by the Seller and will be effective only upon full satisfaction by Seller.

- **LIABILITY:**The Buyer shall not use the PNG for any illegal or unlawful activity or for purpose other than mentioned in clause 5.2. In case of any offense under or violation of any law, statute or regulation by the Buyer, the Buyer alone shall be responsible and liable for the said offense or violation and the Buyer agrees to indemnify and keep indemnified the Seller from and against any loss, claim, action or proceeding that may be suffered or incurred by the Seller as a result of any such offense or violation by the Buyer.

Accordingly the Buyer shall protect, indemnify and hold the Seller harmess against all claims, demands, action, suits, proceedings, judgments and all liabilities, costs, expenses. damages or losses arising out of or resulting from or incidental to or in connection with the supply of PNG/provision of PNG connection.
